Meet the Nurses/Medication/Health Care Plan Drop-off

There are several opportunities to meet our nurses and drop-off student medication/health care plans:

Monday, August 5 from 5:30-6:30pm in the Gym

New families can meet us inside the gym before/during New Family Orientation on August 5. Returning families, please utilize the Gym delivery door entrance (on the east side of the building) for drop-off to avoid interruptions to the New Family Orientation.

Tuesday, August 6 from 7:30-9:00am & 11:30am-2:30pm, Gym East Entrance

We will be available in the Gym, entering from the delivery door (on the east side of the building) during scholar orientation from 7:30-9:00am & 11:30am-2:30pm.

If your scholar has a health concern/condition OR if your scholar takes a daily, as needed, or emergency medication - we want to connect with you! Please come meet us for medication and/or health care plan drop off. Allowing Trivium Prep to help support a safe and healthy school year for all.

We stock the following over the counter medications in the health office: Acetaminophen/Tylenol, Benadryl, Cough Drops, Ibuprofen, Hydrocortisone cream, Neosporin, Saline Eye Drops, Tums.

All medication requires a <u>Consent to Dispense</u> form, giving us permission and guidance to administer the medication. Any medication provided must be in the original packaging or prescription bottle labeled with your scholar's name and correct administration directions.

As a reminder, scholars cannot bring medication on campus. This includes over the counter medication, for example: allergy medication, pain relievers, topical creams. This is to help protect the safety and wellbeing of all. The health office is happy to house medication for your scholars' every need, anything from allergy medication to short term antibiotics, eczema creams/lotions or back up inhalers, your child's health and safety is our top priority.

Scholars may be permitted to self-carry emergency medication (Epi-pens, inhalers, and quick glucose) with a completed emergency action plan and Self Carry Form. This form confirms you are confident your scholar can use the emergency medication correctly, at the appropriate times and they are responsible for keeping it with them (I recommend a pencil bag that travels with them throughout the day.) Your scholar will be asked to demonstrate/verbalize the correct way to self-administer the medication, the health office may provide further education if needed.

We welcome all information or guidance to help support your scholars on campus to the best of our abilities, it helps to have guidance directly from their health care providers as well. Great hearts has a few health care plans or action plans to help guide care:

- Allergy Action Plan
- Asthma Action Plan
- Migraine Action Plan
- Seizure Care Plan

If your scholar has one of the above-mentioned medical conditions - an action plan is required. We do accept action plans from the provider's office as well. **These must be updated annually.**
